**ORDER**

(U/S 34 of Disaster Management Act, 2005)

The outbreak of Novel Corona Virus (COVID-19) is a potential threat to the human life and measures are being taken by the District Disaster Management Authority to create awareness amongst the general public and to contain the entry/spreading of the virus in the District.

And therefore, it is necessary to take immediate preventive or mitigation step by the concerned for containing the spread of the virus & loss of lives in the District.

Considering the gravity of the situations, therefore, in exercise of the powers conferred by Section 34 of the Disaster Management Act, 2005, I hereby direct the following which are as follows:

1. **All Business Establishment & Shops (except essential commodities)** throughout Cachar District will remain closed on 6.00 AM of 23<sup>rd</sup> March, 2020 to 9.00 PM of 24<sup>th</sup> March, 2020.
2. **All the Malls including Goldighi Municipal Mall** throughout Cachar District will remain closed w.e.f. 23<sup>rd</sup> March, 2020 until further order.
3. **All the Weekly Markets** throughout Cachar District will remain closed w.e.f. 23<sup>rd</sup> March, 2020 until further order.
4. **All the Fish/Meat markets (including selling in open markets as well as in designated markets)** throughout the Cachar District will remain closed w.e.f. 23<sup>rd</sup> March, 2020 until further order.

Non-compliance of the above directions, action will be taken as per section 51 of Disaster Management Act 2005.

This order comes into force with immediate effect.
