**Subject: Fixation of essential commodities rates – regarding.**

**ORDER**

In exercise of clause (I) sub section (2) of Section -10 of Disaster Management Act, 2005 vide Ministry of Health and Family Welfare order no. X.11035/136/2020-DR Dated: 13-03-2020, wherein all State/UT Govt. were directed to deal with the situation arising out of COVID-19 to ensure availability of surgical and protective masks, hand sanitizers and gloves as well as with the power vested under Section -3 (2) of the essential Commodities Act, 1955 to the District Magistrate and in adherence to the notification issued under F.No. 26 (1)/2020/ECR&E Dated:13-03-2020, Ministry of Consumer Affairs, Food & Public Distribution under which mask (2 ply, 3 ply, Surgical mask, N95 Mask) and Hand Sanitizer which were declared as essential commodities under Essential Commodities Act, 1995.


The rate of following items shall be as follows:-

1. Surgical 3ply mask : Rs. 27/-
2. Surgical 2ply mask : Rs. 25 /-
3. N95 : i) 3m Rs. 320/-  
ii) Venus Rs. 250/-  
iii) Without brand Rs. 150/-
4. Normal Cotton mask : Rs. 50/-
5. Sanitizer : rate charges as per MRP label.

❖ No hoarding, black marketing and profiteering of these items shall be done.

In case of any violation, the essential commodity (s) shall be confiscated and penal action as mandated under law shall be taken.
