**ORDER**

It is hereby decided that the 50 Model Hospitals in different locations in the State will be each converted into a **COVID-19 treatment facility**, having capacity of 50 patients.

2. The Human Resources deployment in each Model Hospital exclusively for COVID-19 patients will be as follows:-

Category	Number
Doctors	8 (eight) doctors in 2 (two) groups. Each group will have 2 (two) allopathic doctors and 2 (two) ayurvedic doctors/ CHO. There will be 2 (two) additional doctors identified as reserve.
Nursing Staff	16 (sixteen) nurses in 2 (two) groups Each group will have 8 (eight) Nurses each.
Gr-IV ward boy etc.	4 (Four) in 2 (two) groups
Other categories	As required

3. The shift-wise teams will be constituted from amongst the above personnel.
4. The Model Hospitals will treat COVID-19 patients who are either asymptotic or have mild symptoms. Any COVID patient who has low oxygen saturation level or requires specialised treatment, will be referred to either the District Hospital or Medical College Hospital.
5. Director of Medical Education, Assam will list out 100 Pre-Registration Clinical Assistants from the Medical College Hospitals, who will be deployed in the Model Hospitals in the role of supporting allopathic doctors.
6. Director of Health Services, Assam and Executive Director, National Health Mission and will jointly depute doctors and nursing staff working under National Health Mission/ Directorate of Health Services, and form teams for each hospital.
7. A team leader will also be identified for each Model Hospital from amongst the deputed allopathic doctors, who will be responsible for smooth management of patient care.

8. Once the manpower deployment is finalized, each of the 50 team leaders will attend a training programme at Guwahati where administrative and clinical aspects of COVID-19 patient management will be highlighted.
9. Concerned Deputy Commissioner and Joint Director of Health Services will closely monitor the functioning of the Model Hospitals and ensure that all necessary logistical support is provided to the doctors and staff.
