Sir,


In inviting a reference to the subject cited above, I am to say that the Govt. after careful consideration have decided to allow daily diet allowance for the doctors & paramedical staffs engaged in the government run Covid Care Centres, Covid Health Centres and Covid Hospitals @Rs.240/- (Two hundred Forty only) per doctor & paramedical staff per day. The above diet cost will be met out of CMRF.

The daily diet allowance for doctors and paramedical staffs shall be implemented immediately with prospective effect. The controlling Authorities will ensure to provide quality diet to the doctors and paramedical staffs engaged in the above three institutions.

The said allowance will be extended in the form of food and no financial incentives in this regard will be claimed/provided.






