Sub: Strict Monitoring of Persons under Home Isolation


Sir,

It has been directed vide Order No.4175/R&DM(DM) dated 13.7.2020 and No.4379/R&DM(DM) dated 23.7.2020 that all COVID-19 positive cases, who are asymptomatic/ have mild symptoms and have no co-morbidities shall be allowed home isolation, subject to assessment of availability of separate room & toilet at the home of the person and following all protocols for home isolation laid out by Department of H&FW Department, Govt. of Odisha. This strategy was formulated with a view to keeping the asymptomatic/ mild symptomatic Covid-19 positive persons with no co-morbidities in the friendly home environment and monitoring their health along with reducing the load on hospital infrastructure.

Persons staying in home isolation in both rural and urban areas are to be religiously monitored by the GP Nodal Officer (GPNO)/ Ward Nodal Officer (WNO) to ensure that they follow the prescribed protocols. Besides, elaborate arrangements are to be made for monitoring the health of such persons and provide them with required medical assistance at the earliest possible time.

You are hereby instructed to make necessary arrangement to monitor the above at the Districts level on daily basis. The District Emergency Officer will be responsible for collection of data on home isolation from the Blocks, compilation of the same and transmission to the Office of SRC on a daily basis in the format enclosed.




