In continuation to Order No. POL.75/2020/PtI/62, dated 1st September, 2020; the following additional activities are permitted to resume in the State **with effect from 26th October, 2020:**

1. Private Skill Training Providers registered with the Meghalaya State Skill Development Society subject to compliance with the SoPs issued by the Ministry of Health and Family Welfare dated 8th September, 2020 and Ministry of Skill Development & Entrepreneurship vide F.No.B-12011/01/2016-SDE (Part I), dated 11th May, 2020.
2. Driving Schools subject to compliance with the SoP being issued by the Transport Department, Government of Meghalaya.

All entities that wish to resume training should seek permission from the respective Deputy Commissioner confirming strict adherence to the prescribed SoPs. The Deputy Commissioners shall ensure strict compliance to these protocols and guidelines through periodic inspections and regulate the schedule and timing depending on the local situation and to meet the social distancing norms.
